WHAT IS IT?

OBJECTIVES

How to play?

DURATION?

We recommend a training session with the following characteristics: face-to-face training through INTEGRITY NOW!®:

- Game 90 min.
- Pause 10 min.
- Discussion and evaluation 80 min.
- Resume and questions 20 min.

Participants should discuss and develop each case freely directed by the moderator, who should be a compliance expert. We recommend that a moderator or expert coordinate a maximum of two games or tables, to allow enough time to meet the training objective.
